The most commonly used definition of the term sustainability is the so-called Brundtland-definition, which was presented by The World Commission on Environment and Development in 1987:

"A sustainable development is a development that meets the needs of the present without compromising the ability of future generations to meet their own needs."

Most people associate the term sustainability with green technology and nondepletable energy. But sustainability can also be about creating a balance within an individual or between individuals.

In other words, the premises for development and growth is that it cannot be at the expense of the welfare of the society, the environment or any human being.

SOCIAL ENTREPRENEURS

DUGNAD – SUSTAINABLE LOCAL SOLUTIONS

“Dugnad” is a Norwegian word for gathering of the local community in order to solve a conflict or perform a task. Everyone contributes in the way they are capable.

DUGNAD Vesterbro is a grassroots organisation working to improve the conditions for drug users in the neighborhood of Vesterbro in Copenhagen.

The first “Dugnad” was organized and held in 2005 with residents, politicians, drug users and others came up with 101 different solutions to how the residents and drug users in Vesterbro can live together sustainably.

Today, those solutions have resulted in many initiatives, among others the DUGNAD association, a [health room](#), a [cafe called DUGNAD](#), a chair design, and a specially made needle container for the drug users. Additionally, a street newspaper called [Gadeavisen](#) and an [art calendar](#) have been designed along with the catering concept [JunkFood](#) which is generating money for the different activities. And last but not least, the Dugnad resulted in the abolition of a couple of banned zones where the drug users were not allowed to be ([see tv interview here](#)).

The focus on solutions and not problems, the creation of partnerships across sectorial boundaries, the involvement of many interests and the development of (unique) user-driven solutions is something we can all learn from and be inspired by in DUGNAD’s work.
